# ISO 37101 Management Systems for Sustainable Development in Communities

# What is ISO 37101?

ISO 37101 is an international standard which specifies the requirements of and provides guidance on the establishment of a management system for sustainable development in communities. The standard aims to help organizations and communities establish a framework that allows them to improve their standing in their social, economic and environmental aspects. The requirements of the standard can be applied to communities of all sizes in their sustainable development efforts towards smart, more resilient and more efficient infrastructure and ultimately help improve their overall well-being. The standard addresses specific sustainability issues such as governance, education, innovation, health care, interdependence, safety, inclusivity, etc., and has the flexibility of adding other sustainability issues which may prove relevant to the community implementing it.
